

Privacy Policy

Acceptance of Terms

This Privacy Policy applies to the website: www.driprunner.us (the "Site") and does not govern privacy practices associated with offline activities. These are the guidelines used by Drip Runner, LLC ("COMPANY") in protecting your privacy. COMPANY reserves the right to modify these terms at any time and in any manner, without prior notice.

COMPANY respects your privacy and is committed to protecting the information you provide us through the Site. We do not sell or distribute user information to unaffiliated third parties, except as needed to provide services that you have requested. COMPANY's website is powered by BLUEHOST, which may collect and use certain user traffic and click data. Please see BLUEHOST's privacy policy for more information. COMPANY is not liable for BLUEHOST's use of data gathered from this Site.

a. <u>User Information</u>. During your interaction with the Site, COMPANY may request information from you. The only information COMPANY will collect and store about you is information you decide to provide us. If you have voluntarily submitted user information to us through an email or contact form or any other information, COMPANY will only use such information for the purpose that it was provided or as otherwise permitted by law.

b. <u>Other Information</u>. COMPANY may use server logs to record a visitor's Internet Protocol (IP) address and to collect general information about the visit to the Site, such as the time and length of the visit, and the web pages accessed during the visit. COMPANY may use this information for Site management and performance monitoring only. COMPANY does not make this information available to unaffiliated third parties, but may share it with affiliated companies.

c. <u>Cookies</u>. COMPANY and/or its third party providers may use cookies from time to time to allow COMPANY to tailor the Site to your preferences or interests, customize promotions or marketing or identify which areas of the Site are more popular. A cookie is a small, unique text file that a website can send to your computer hard drive when you visit that site. If you do not want COMPANY to deploy cookies in your browser, you can set your browser to reject cookies or to notify you when a website tries to put a cookie on your computer. d. <u>Security</u>. To prevent unauthorized access to any user information, COMPANY has put in place commercially reasonable physical, electronic, and managerial procedures to safeguard and secure the information it collects through this Site. However, COMPANY cannot guarantee the security of such information.

e. <u>Child Privacy</u>. The Children's Online Privacy Protection Act prohibits COMPANY from collecting any identifiable information from anyone under the age of thirteen (13) without parental permission.
